



COVID-19 - HEALTH PROTOCOL

French Historic Grand Prix - 11 - 12 -13 June 2021

The event is on the list of major international sporting events authorised in France (DIGES), in recognition of the imperative nature of the event.

In the current context, we would like to inform you that the event will take place with a reduced audience of 2 bubbles of 5,000 spectators with temperatures taken at the entrance to the circuit.

The protocol may change according to any changes in the instructions. Find all the latest information updated on www.hvmracing.fr

Given the health crisis and for all the participants, it is recommended that you follow the following social distancing measures which are part of the health protocol as defined by the competent authorities, in order to fight against the spread of Covid-19.

GENERAL MEASURES TO BE RESPECTED

- You must keep a distance of 1 metre from other people in all places, particularly during the podiums, in the pre-grid, in the pits, paddocks and stands.
- You must wear a mask in the circuit even if you are able to keep a distance of 2 metres from other people.
- Compliance with curfew 11h pm.
- Hand sanitiser will be available in the different focal points (HVM Office, Circuit Reception, Race Management, College, Technical Room).
- The sanitary facilities (showers and toilets) will be open and will be cleaned and disinfected very regularly.
- All members of the organisation and reception team must present a negative test for Covid-19 taken less than 72 hours ago on arrival at the site.
- Competitors and their teams must present a PCR test taken less than 72 hours ago, or a "pass sanitaire" (French health pass). Antigen tests* will be carried out at the entrance of the circuit if you do not have one.

We ask you all to be responsible and:

- To respect the social distancing measures stated on page 2 and 3 of this documents.
- To bring your own masks and bottles of hand sanitiser.
- Avoid groups of more than 6 people as much as possible.

ORGANISATION DETAILS:

Specific measures:

- Open air public relations operation (behind the boxes)
- Podium procedure changed in order to limit clusters.
- Constant rotating disinfection of the common areas in addition to the usual sanitary facility cleaning.
- "Covid Manager" appointed. This will be the person responsible for checking that the sanitary measures implemented for this event are respected. And generally speaking, all the social distancing measures. A team will be specifically appointed to ensure compliance with the rules.
- Any person showing symptoms will be directed to an equipped COVID isolation centre on-site.
- Any person suspected of being infected or who falls ill during the event will be taken to this facility immediately. Medical staff wear full protective equipment (FFP2 masks, gowns, gloves, etc.).
- All staff are informed of the location of this centre and the procedures to follow should they fall ill

Participants:

- Masks must be worn.
- Negative PCR tests taken less than 72 hours ago a valid vaccination certificate or a "pass sanitaire" (French health pass).
- Compliance with social distancing measures
- The organisation will be able to provide masks as a back-up.
- The competing Teams' organisation must not include any catering or hospitality.
- Brief document distributed in electronic and paper versions beforehand.

Organisation:

- Everyone must wear a mask.
- Negative PCR tests taken less than 72 hours ago for everyone, a valid vaccination certificate or a "pass sanitaire" (French health pass).
- All the administrative formalities will take place under outdoor display areas with queues and social distancing.
- Briefing meetings will take place by video conference and not in person.
- The number of officials will be limited to the strict minimum.
- Track safety car: 2 people maximum, with masks.
- Rider's area in team structures closed except for vehicles called up for inspection.
- Pre-grid: Only the mechanic is allowed.
- Commissioners should prioritise taking Meals outside.
- Our catering provider will be implementing adequate sanitary measures in accordance with the protocol and operating framework defined by the government.

Exhibitors:

- Must wear a mask.
- Negative PCR test taken within the last 72 hours, a valid vaccination certificate or a "pass sanitaire" (French health pass).
- There are clearly demarcated queue lines and social distancing.
- Only use recyclable disposable cups.
- For the refreshment stands: Terrace areas must be spaced out pursuant to the catering standards in force at the time. For take-away counters: Intercom and demarcated queue lines with social distancing.
- The refreshment stands must be located in areas that allow for a queue long enough to respect the distances.
- No gatherings.

- Exhibitors must sign a charter undertaking to adhere to the healthcare rules (Annex 1).
- Any failure to comply with the instructions will result in the exclusion of the exhibitor and his equipment.

Public:

Maximum 2 zones with 5000 people / day

- Must wear mask and comply with social distancing measures.
- There will be members of the organisation supervised by the Covid manager in each public area to ensure that the rules are respected.
- Number of invitations limited to 500 / day
- Public allowed in certain areas without access to other areas.

. Online ticketing:

- All tickets sold, free tickets (under 15) and invitations will be generated via an electronic ticketing platform. All bookings will come with a specific charter with a simplified health questionnaire (name, first name, address), a reminder of the social distancing measures and instructions to be followed. This charter must be accepted in order to obtain tickets.
- Any person entering or leaving the circuit is "bleeped".
- This allows us to control the number of people on site at all times.

. On-site ticketing:

- We are going to prioritise the Pre-sale, only the number of tickets to reach maximum capacity will be sold on-site.
- Reminder of health protocol and social distancing measures.
- Box offices with intercom and social distancing. Separate queues. The aisle where the ticket offices are located is about 5m wide and 100m long.
- No programme will be distributed.

Penalties:

Failure to comply with the rules will result in the exclusion of the offender.

Basis of rules in force 23 March 2021

HYGIENE MEASURES

- - Regularly wash hands with soap and water (disposable towels must be provided to facilitate this) or by hydro-alcoholic friction
- Systematically cover your nose and mouth when coughing or sneezing into your elbow
- Blow your nose in a single-use handkerchief to be disposed of immediately in a non-hand-held waste bin
- Avoid touching your face, especially your nose, mouth and eyes or touching your mask
- Do not shake hands or kiss to greet others, do not hug

SOCIAL DISTANCING AND MASKS

- Systematically wear a mask in enclosed and shared areas
- Maintain a physical distance of at least one metre
- Increase the distance to two metres when the mask cannot be worn, in the situations provided for in the Ministry of Labour's question/answer (mentioned on p. 8) or in collective catering areas, as well as in outdoor areas

OTHER RECOMMENDATIONS

- Regularly ventilate closed rooms (the HCSP recommends ventilation for a few minutes at least every hour) or ensure adequate fresh air supply through the ventilation system which is regularly checked and complies with the regulations
- Regularly clean objects and surfaces, including sanitary facilities, with a product active against the SARS-CoV-2 virus
- Dispose of potentially contaminated waste in non-hand-held bins
- Avoid wearing gloves: they give a false sense of protection. The gloves themselves become transmission vectors, the risk of touching your hands to your face is the same as without gloves, the risk of contamination is therefore equal or even higher. Should a person in the workplace display symptoms, implement the protocol provided for in Chapter V - Temperature self-monitoring by employees: a systematic temperature check at the entrance to establishments/structures cannot be mandatory. However, everyone is invited to check their own temperature if they feel a fever before leaving for work and, more generally, to self-monitor for any symptoms that could be Covid-19
